# YOUR BENEFITS EXPLAINED

	SILVER	GOLD
<b>MONTHLY PREMIUM</b>	€21 per month	€31.50 per month
<b>OUT OF WORK BENEFIT</b>	€180 per week	€250 per week
This is payable for every full week that you're unable to work following an equine-related accident. You'll receive this benefit until you can return to work, up to a maximum of 26 weeks. No benefit is payable for the first 2 weeks of disablement.		
<b>HOSPITALISATION BENEFIT</b>	€150 per week	€220 per week
This is payable for every full week you're in hospital as an in-patient following an equine-related accident. You'll receive this benefit until you leave hospital, up to a maximum of 10 weeks. No benefit is payable for the first 2 weeks of hospitalisation.		
<b>SERIOUS INJURY BENEFITS</b>		
<b>ACCIDENTAL DEATH</b>	€10,000	€15,000
<b>PERMANENT TOTAL DISABILITY</b>	€10,000	€15,000
<b>FRACTURE BENEFITS</b>		
<b>SKULL, LEG, KNEECAP, ANKLE, ARM, WRIST, COLLAR BONE</b>	€350	€400
A fracture means a breach in the continuity of the bone caused by an accident which is identified by an x-ray or in the case of a fracture which is unable to be x-rayed, by confirmation from a doctor.		

## WHAT ISN'T COVERED?

- ▶ This policy covers you whilst taking part in, practicing or working in equine related activities and sports
- ▶ Accidents during the first 7 days (unless you are claiming for a Serious Injury Benefit)
- ▶ Full-time professional sports
- ▶ Being under the influence of alcohol or drugs

## WHO CAN APPLY?

- You must be:
- ▶ Between the ages of 16 and 64 inclusive
  - ▶ Resident in the Republic of Ireland
  - ▶ Employed and working for a minimum of 16 hours per week, or self-employed
